# NOTICE IN TERMS OF SECTION 15 OF THE PROMOTION OF ACCESS TO INFORMATION ACT, 2000

## Automatically available records and access to such records

(in terms of Section 15 of the Promotion of Access to Information Act, 2000 (Act No. 2 of 2000)

and

[Regulation 4 of the Regulations relating to the Promotion of Access to Information, 2021]

#### 1. INTRODUCTION

- 1.1 Section 15 of the Promotion of Access to Information Act, 2000 (Act 2 of 2000), stipulates that "the Information Officer of a public body, referred to in paragraph (a) or (b)(i) of the definition of a "public body" in section 1, must make available in the prescribed manner a description of-
  - (a) the categories of records of the public body that are automatically available without a person having to request access in terms of this Act, including such categories available-
    - (i) for inspection in terms of legislation other than this Act;
    - (ii) for purchase or copying from the body;
    - (iii) from the body free of charge; and
  - (b) how to obtain access to such records.
- 1.2 The Eastern Cape Department of Sport, Recreation, Arts and Culture has updated the Section 15 Notice and is in compliance with the provision of Section 15(2) of the PAIA of 2000, which gives access to records that are automatically available.
