I, Sibulele Ngongo, Member of the Executive Council responsible for Sport, Recreation, Arts and Culture in the Province of the Eastern Cape, acting in terms of Section 5(1) of the Eastern Cape Provincial Arts and Council Act, 2000 (Act No.6 of 2000), hereby invite the public, artists and arts and culture organizations to nominate persons, who will serve as members of the Eastern Cape Provincial Arts and Culture Council.

Such individuals must have special knowledge or experience in the following fields of Theatre and Performing Arts, Film, Visual Arts and Crafts, Language and Literature, Music and Dance, Community Arts, Exhibitions, Festivals and Campsites.

Specialist skills in Finance (fundraising, accounting), Law and Human Resource Management / Administration.

Nominations must be accompanied by the following:

- a detailed Curriculum Vitae of the nominee containing the full names, address, telephone, fax and/or e-mail address of the nominee;
- reasons for the nomination; and
- signed acknowledgement by the nominee that he or she accepts the nomination.

The Council must reflect broadly the demographics of the province, in terms of race, gender, youth and physically challenged individuals.

Appointed members of the Council would be expected to render their services to the council on a voluntarily basis and would only be compensated, as the MEC may determine, for the reasonable and necessary travel and accommodation costs incurred in rendering such services.
